## A WORD FROM THE SHERIFF:

As your Sheriff I believe that taking a preventative approach to our most common complaint is one of the best ways we can serve the community. I am repeating this past article, as speeding complaints are still our communities' number one concern. We are taking aggressive enforcement in communities, and this means that we are issuing citations. It is something that no one wants to receive, but we have to protect your families and pets. You control the outcome, just slow down; it's not worth the life you will impact!

Speeding complaints in neighborhoods are number one complaint and concern generated from our local community. We all believe that ensuring the safety of our children, our community members and our pets is a very important part of law enforcement and neighborhood partnerships. In many neighborhoods most neighbors will agree that not everybody exceeds the posted speed limit however it's important to remind our family household members as well as visitors that it is incumbent upon everybody to make a conscious effort to watch their speed when entering a neighborhood.

Most of the time when our office receives complaints about speeding it's always one or two identifiable vehicles or persons whom are the reason the neighborhood feels there is a speeding concern. We've taken the approach to take anonymous tips about these one or two speeding persons and a deputy will personally visit the household and remind them of the speed limits. It's funny because in most occasions the families are very apologetic and didn't even realize their actions and appreciated us reminding them instead of issuing citations. We are all leading busy lives, kids, appointments and so much more. It's easy to forget!

Although in some neighborhoods we have not received speeding complaints it is important to remind everybody as spring is quickly approaching it's important to pay attention to the speed limits that are set both in your community as well as our surrounding neighborhoods and roadways. If you could just share the simple message with friends and family that is very important for everyone safety to maintain a safe speed and obey the speed limits that are set.

## Evidence Update

The Evidence Technician is responsible for all property that is brought into the Office of the Sheriff. All items must be properly analyzed, sealed, preserved, stored, logged in, entered in the computer system, and the chain of custody maintained at all times. The technician is also responsible for collecting and processing fingerprints, latent prints, DNA and biological and forensic samples. Weapons and Controlled Dangerous Substances (drugs) are also collected, processed and held for various reasons. The technician investigates and processes applications for the return of firearms and other property and performs the legal disposition and destruction of property.

The Evidence Technician assists deputies with collecting, processing, logging, and documenting items at the scene or within the office environment. The tech analyzes the case, notes from the scene, various reports and supplements as well as the property itself to determine if it is collected, found/recovered or evidence of a crime. Evidence requires analysis, which is coordinated by the technician, utilizing resources at the Maryland State Police Crime Laboratory and other agencies. It is imperative that proper documentation exists on paper and in the computer system for each item collected and held.

An important duty the Evidence Technician performs is to assist deputies and citizens with the disposition of property; for example, items processed must be returned to the owner, held for further investigation or presentation in court, or destroyed according to law and policy. When the Office of the Sheriff receives report of a burglary, for example, and a stolen item is recovered through our investigation, it is held in Property until the owners are notified. The technician serves our citizens of Queen Anne's County by properly maintaining, caring for and returning their property. The Evidence Technician, along with the First Sergeant, investigates and processes applications for the return of firearms, ensuring compliance with statutes, regulations and policy. The tech must keep advised of weapons-related, domestic violence, mental health and other statutes to ensure proper handling of firearms for the Office of the Sheriff.

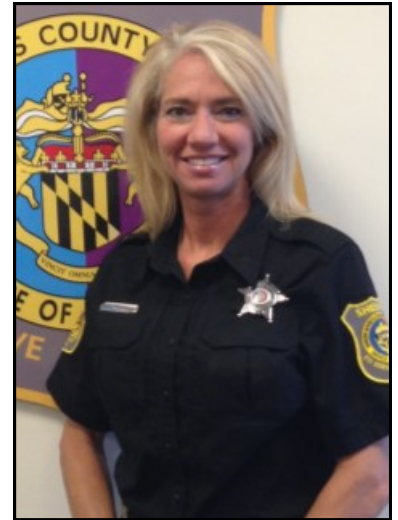
The Evidence Technician provides numerous reports to the Sheriff on a monthly basis. Along with the Administrative Commander, the tech performs monthly inventories of scheduled property area(s) and performs NCIC Validation check of stolen items.

"Since I became a Police Officer in 1991, the processing of evidence has changed considerably. DNA and technology are utilized much more and we are able to impart valuable information for analysis, both for prosecution and exculpatory purposes.

It is imperative that each item of property taken into the Office of the Sheriff is handled professionally, sensitively and legally. We are responsible for the items in our care and all of them are important; whether it's Grandma's priceless heirloom recovered in a burglary investigation or a lost cell phone.

For all items including CDS (controlled dangerous substances), firearms, or other evidence, we are responsible for the proper chain of custody and that items are handled safely and according to law. Evidence and property is held in a video-taped secure environment, behind at least two locked doors – more security is utilized according to CALEA standards, with firearms, CDS, and designated valuable items.

The deputies of the Queen Anne's County Sheriff's office work tirelessly to ensure we appropriately handle and manage the property belonging to our citizens and courts." said Kaarin Salisbury

## Our response to your calls for service:

The Queen Anne County Office of the Sheriff Field Operation Division during the first quarter of 2013 handled 6,120 incidents which resulted in 424 initial investigation reports and 370 supplemental reports. Made 84 on-view arrests and completed 61 applications for charges as a result of criminal investigations conducted.

Also served 164 arrest warrants. Field Operation Division served 831 civil process papers. Issued a total of 1,457 traffic citations, warnings, equipment repair orders, and parking citations.

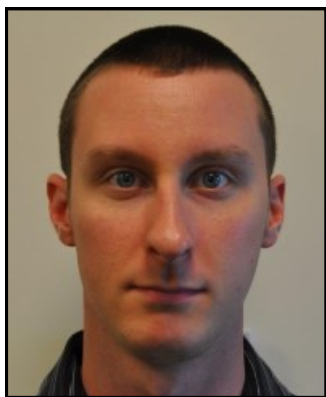

The Office of the Sheriff is pleased to announce the graduation of two personnel from the Eastern Shore Criminal Justice Academy. Deputy Rudy Draper and Deputy Andrew Neall graduated on June 17, 2013 and will now begin field training in the Patrol Division.

## Traffic Safety

The Queen Anne's County Office of the Sheriff is dedicated to your safety while traveling our roadways. Deputies work hard to keep our roads safe through education, training, and traffic enforcement efforts. Here is a brief highlight of some of their efforts.

In March Deputies provided information cards on seatbelt use to parents at several schools in the county. Each card explained the current seatbelt laws, child safety seats, booster seats, and related requirements in Maryland.

April brought attention to Distracted Driving. Distracted Driving is increasing as a contributing factor in motor vehicle crashes. Sheriff Hofmann and Deputy Armington filmed a short informational video detailing

Distracted Driving. The video was posted on Facebook and YouTube. Deputies attended a refresher course on Standard Field Sobriety Testing to keep their skills fresh and up to date. A Deputy also attended the National Lifesavers Conference that focused on the current trends, new training, and equipment available to keep motorists safe.

May was a busy month for traffic safety with the beginning of the summer season. Deputies participated in the National Click It or Ticket campaign and continued DUI saturation patrols in the county. The monthly Traffic Safety video was filmed and posted on Facebook and YouTube.

June was another busy month with the Smooth Operator campaign. Deputies contin-

ue to participate in grant funded traffic enforcement. Deputy Michael Jordan attended the DUI Institute sponsored by the University of Maryland. Deputy Jordan's enforcement effort against drunk drivers has placed him in the top ranks among patrol.

Since March, during these grant funded traffic enforcement details, your Sheriff's office has issued 143 traffic enforcement papers (citations, warnings, and equipment repair orders). 1 person was arrested on an outstanding warrant. 2 people have been arrested for driving under the influence of alcohol, 1 person for possession of a controlled dangerous substance, and 3 people for driving on a suspended/revoked license. These efforts do not include daily patrol activities.

## DRUG TASK FORCE

The Queen Anne's County Drug Task Force is a multi-agency task force aimed at combating mid and upper level drug dealers in Queen Anne's County, Maryland. The task force board is comprised of members of the Maryland State Police, Queen Anne's County Sheriff's Office, the Centreville Police Department, the Maryland Department of Natural Resources Police and the Office of the Queen Anne's County State's Attorney.

The Queen Anne's County Drug Task Force reports quarterly to the Task Force Advisory Board. The benefit of the Task Force concept is that it lessens the manpower and budgetary constraints on each participating agency.

The investigative case load carried by the task force grows every year and many of the crimes investigated have roots or ties in other counties and/or states. Investigators at the task force routinely work closely with the FBI, the DEA, the ATF, neighboring drug task forces and state and federal prosecutors to bring these cases to a successful conclusion and to ensure that all persons involved with the drug/criminal networks are brought to justice, no matter where they live.

Investigators with the task force also routinely work hand in hand with the CID units at the Centreville Barrack and the Queen Anne's County Sheriff's Office to investigate thefts, robberies and crimes of violence that often have their roots in the use and sales of narcotics.

The Queen Anne's County Drug Task Force is a financially self-sufficient unit, operating off of seized assets at no cost to the taxpayers of Queen Anne's County.

Besides using seized, drug related funds to pay for day to day operational expenses, the task force routinely pays for training, equipment and other related costs occurred by member agencies.

## Fingerprinting Services

*Critical Update on our Fingerprint Services*

As of September 20, 2012 the FBI will no longer be accepting inked fingerprint cards. All fingerprints should be electronically or digitally captured and are to be electronically submitted to The Maryland Criminal Justice Information System-Central Repository (CJIS).

Our office is pleased to announce that we will be able to comply with the NEW 'Electronic-Only Processing' policy that has been put in effect by the FBI. With the new FBI policy several changes are being made to our current fingerprint procedures.

- Our office will be fingerprinting **Monday-Friday from 8a.m. to 8p.m.** and there will be a **\$20.00 fingerprint fee {with no card limit}**.
- You will need to bring the Background Check form printed by your employer with your fingerprint Authorization Code on it.
- The Associated CJIS -CR Fees are :
  - Full Background {State & Federal} for authorized agencies only \$34.50
  - Child Care Volunteers \$33.00
  - State background check only \$18.00
  - With gold seal \$19.00
  - Attorney/Client Civil \$18.00

- You will need to also bring a **Photo ID** and a **Check or Money Order ONLY** made out to *Queen Anne's County Office of the Sheriff* for your payment. Be sure your payment include the \$20.00 fingerprint fee & the associated CJIS-CR Fees.  
(Fingerprint Fees are mandated by the State & Federal Government)
