As your Sheriff, we want to thank you for your support to our agency as we continue to support the citizens of Queen Anne's County with integrity and pride. We remind you that we are always available to answer any questions, meet with your community groups, or speak with you individually. Just give our office a call to set up a convenient appointment.

We continue to take the COVID-19 crisis very seriously and will remain cautious in our approach with our families, co-workers, and the community for as long as it takes to keep our citizens safe. We remind everyone to continue to exercise the CDC-recommended universal precautions and if you have any questions, contact the local COVID Hotline at 443-262-9900.

Our community's number one concern continues to be speeding complaints. As your Sheriff, I believe that taking a preventative approach to our most common complaint is one of the best ways we can serve the community. We provide aggressive enforcement in communities and this means that we are issuing citations. It is something that no one wants to receive, but we have to protect your families and pets. You control the outcome— JUST SLOW DOWN! It is not worth the life you will impact!

While speeding complaints in neighborhoods are the number one complaint and concern generated from our local community, we all believe that ensuring the safety of our children, our community members and our pets is a very important part of law enforcement and neighborhood partnerships. In many neighborhoods, most neighbors will agree that not everybody exceeds the posted speed limit; however, it is important to remind our family household members, as well as visitors, that it is incumbent upon everyone to make a conscious effort to watch their speed when entering a neighborhood.

Most of the time when our office receives complaints about speeding it is usually due to one or two identifiable vehicles or persons. We have taken the approach to accept anonymous tips about these speeding individuals and a deputy will personally visit the household and remind them of the speed limits. In most cases, the families are very apologetic and do not even realize their actions and appreciate us reminding them instead of issuing citations. We are all leading busy lives with family, appointments and so much more. It is easy to forget!

Her specific job duties include handling and processing all the Protective, Peace, and Extreme Risk Protective Orders for the entire county; entering all citations in to the records management system; the validation of records in the state and national systems; the processing and release of police and accident report requests; and, answering phones. Amanda is also responsible for registering all personnel for trainings, completing 'Most Wanted' entries on the Sheriff's Office website, and assisting with fingerprinting services offered to the community.

Amanda looks forward to many more years with the Office of the Sheriff and continuing to get to know the community in which she now works and resides.

Pete Lunn

Pete Lunn joined the Queen Anne's County Office of the Sheriff (QACOS) as the Evidence Manager in July of 2019. It is his job to manage over 4,000 pieces of evidence. Managing evidence means packaging and storing evidence securely, transporting evidence to and from the Maryland State Police Lab, and making the evidence available for court as needed. It also involves purging evidence no longer needed for court and returning evidence and property to the property

owners whenever possible. We also store firearms as a result of Protective Orders and then return them when the orders expire, if allowed. As Evidence Manager, Pete processes all requests for the return of firearms held by the Sheriff's Office for court as evidence. Another important part of the job is to manage the Deputies' 'Body Worn Camera' (BWC) system. Videos from the BWC's are requested almost on a daily basis from the State's Attorney's Office (SAO) for case review and as evidence in court, if needed. The BWC videos are also furnished to the public as a result of Public Information Act (PIA)



requests. Some videos require redactions due to privacy concerns and can take hours, if not days, to process. It is also the job of the Evidence Manager to complete monthly validations of stolen property with the FBI's NCIC Computer System. This involves contacting victims to make sure that their stolen property has never been returned which allows the QACOS to keep their property listed as "Stolen" in the NCIC Computer System. Pete also teaches evidence procedures and packaging to new deputies during their Field Training Program.

Pete is a retired Police Sergeant from Pennsylvania with over 31 years of Law Enforcement experience. He currently resides in Queen Anne's County with his wife of 34 years, Jeanne. They have three sons and two granddaughters.

While working within the constraints imposed by the nationwide COVID-19 pandemic since March of 2020, the Task Force has continued investigating drug crimes occurring within Queen Anne's County.

By focusing on the opioid crisis, the Task Force has seized suspected heroin/fentanyl and opioid-based prescription pills from several persons who are suspected of supplying the drugs in multiple overdoses that have occurred this year. Recently the task force, working closely with prosecutors at the Queen Anne's County States Attorney's Office, charged two persons with manslaughter and a host of lesser charges in the opioid-related overdose death of a local man.

The Queen Anne's County Drug Task Force is a multi-agency task force aimed at combating mid- and upper-level drug dealers in Queen Anne's County. The Task Force board is comprised of members of the Maryland State Police, Queen Anne's County Office of the Sheriff, the Centreville Police Department, the Maryland Department of Natural Resources Police and the Office of the Queen Anne's County State's Attorney. The Queen Anne's County Drug Task Force reports quarterly to the Task Force Advisory Board. The benefit of the Task Force concept is that it lessens the manpower and budgetary constraints on each participating agency.

The investigative case load carried by the task force grows every year and many of the crimes investigated have roots or ties in other counties and/or states. Investigators at the task force routinely work closely with the Federal Bureau of Investigation (FBI), Drug Enforcement Agency (DEA), Homeland Security Investigations (HIS), the Alcohol, Tobacco and Firearms (ATF), neighboring drug task forces, and state and federal prosecutors to bring these cases to a successful conclusion and to ensure that all persons involved with the drug/criminal networks are brought to justice, no matter where they live.

The task force has investigated or assisted with the investigations into hundreds of opioid-related overdoses that have occurred in Queen Anne's County in previous years. The task force, working closely with the Queen Anne's County State's Attorney's Office, the Criminal Investigation Division (CID) unit at the Queen Anne's County Sheriff's Office, and the Maryland State Police have been very successful in charging those responsible for delivering opioids that caused multiple fatal and non-fatal overdoses. Queen Anne's County now has one of the highest success rates for achieving convictions in these cases.

Investigators with the Task Force also routinely work hand in hand with the CID units at the Queen Anne's County Office of the Sheriff and the Maryland State Police to investigate thefts, robberies and crimes of violence that often have their roots in the use and sales of narcotics.

The Queen Anne's County Drug Task Force is a financially self-sufficient unit, operating off of seized assets at **no cost to the taxpayers of Queen Anne's County.** Besides using seized, drug-related funds to pay for day-to-day operational expenses, these seized funds are used to pay for training, equipment and other related costs occurred by member agencies.

Court and Civil Processes



Opening on June 17th, 2019, Circuit Courthouse for the Queen Anne's County has officially been in operation for over a year now. The courthouse has been dealing with the effects of the extended state of emergencv due to the COVID 19 virus. What started as a "Phase I" restriction at the Court with limited services and access, has steadiprogressed to the current ly "Phase IV." Soon, jury trials will begin again. At this time, we are limited to 50 total people inside the courthouse, with no more than 10 people in each courtroom. Public access is still lim-

ited to only those have business who at the Court. While in the Court, we are still observing social distancing and wearing of face COVerings, among other safety protocols, in a continued defense against COVID 19. Electronic hearings for cases will continue to be scheduled so litigants. attorneys, and witnesses can remotely. Sheriff Hofmann has established standards that provide the necessary reports and analyses he needs to make fact-based, informed management decisions.



Patrol Unit

Fall is upon us! The Patrol Unit, the largest unit within the Office of the Sheriff, has been busy keeping up with the forever changing laws. There are a lot of misconceptions out there that make people believe that marijuana has been legalized in Maryland. This could not be further from the truth. Marijuana has only been decriminalized and only if it is in an amount less than 10 grams. What does this mean? It means that if you have more than 10 grams in your possession, it is still a criminal offense just like before. If you possess less than 10 grams, your stash is still going to be seized and destroyed and you will still receive a penalty. Instead of criminal charges though, you will be issued a civil citation and will receive a fine to pay. Not to mention that if you are smoking marijuana while operating a motor vehicle, you could be arrested and charged with numerous other crimes such as "Driving While Impaired by Drugs." These types of charges are going to more than likely cause you to lose your driving privileges along with having to pay some expensive attorney fees. So far this year there have been 135 persons charged with "Possession of Marijuana." There were also eight defendants charged with "Possession of Marijuana"



with an "Intent to Distribute," along with 41 defendants charged with "Possession of a Controlled Dangerous Substance, Not Marijuana."

We also reinstated the **'Deputy of the Quarter'** award. During the second quarter, this award was presented

to Deputy First Class Roger Brown. DFC Brown recently promoted to the rank of Deputy First Class from the rank of Deputy due to his tenure here with the Office of the Sheriff. Currently, we have 34 sworn personnel assigned to the patrol unit to include 24 Deputies/Deputies First Class, four Corporals, four Sergeants, one First Sergeant, and one Lieutenant.

So far this year, deputies have taken 1,935 initial reports and 1,126 supplemental reports. Deputies have made 698 arrests to include persons taken into custody on warrants and for criminal summons services charging with a criminal offense.



Deputies have also conducted 1,353 radar assignments. Radar assignments are generally conducted when we receive complaints about speeding vehicles in a community. One of our most common complaints are speeding vehicles in the communities. Keep in mind that most communities have posted speed limits of 25 miles per hour. These are the areas where there is a lot of pedestrian traffic so please be mindful of your speeds.

This training helps keep the Team up to date on the current trends in helping handle a hostage rescue situation. The SWAT Team is a part-time team made up of members of the Office who have received specialized training in various weapons and tactics.



SCHOOL RESOURCE UNIT

The Queen Anne's County Office of the Sheriff's School Resource Unit is adjusting to the beginning of the school year and the challenges this year brings. With the return of the school year and mostly online learning, the Resource Unit is still patrolling the schools with limited student attendance. During the COVID-19 pandemic, the School Resource Unit has been assisting other divisions within the agency including the Criminal Investigations Unit and the Patrol Division.



K-9 UNIT

The Queen Anne's County Office of the Sheriff K9 Program pleased to announce the addition to the canine unit—K9 Tiger. K9 Tiger was procured through *Tydewater Strategic Services* and is handled by DFC Joe Patakowski. K9 Tiger is a 1 1/2 year old black lab and is certified in narcotic detection. K9 Tiger joins K9 Boss and K9 Konar to assist patrol deputies in several law enforcement functions.



AUXILIARY UNIT

The Office of the Sheriff for Queen Anne's County has an Auxiliary Deputy program to assist deputies and the Office with certain tasks and events. These positions are filled by civilian volunteers and are a great help to the Office. Due to COVID-19 the Office has not had many events this year to participate in. Safety first! Thoroughly inspect all candy before allowing children to eat it. Enjoy your candy after inspecting for discoloration, tears in wrappers, an unusual appearance or tiny pinholes. Throw it out if anything looks unsure to you.

We would like to remind our residents that all pedestrians trick-or-treating should cross the street at corners, use traffic signals, and utilize crosswalks when available.

Children under the age of eight (8) should not be alone at night without supervision. If kids are mature enough to be without supervision, they should stick to familiar areas that are well lit and stay together in trick-or-treat groups.

Always walk on sidewalks or paths. If there are no sidewalks, walk facing traffic as far to the left as possible. And remember, ALWAYS bring a flashlight!


