Awards and Commendations

I. Purpose

The Office of the Sheriff for Queen Anne's County expects a high level of professionalism from its employees. When employees exceed the minimum standards of the Office it is appropriate for them to be commended. The official commendation of such performance, and the arrangement of appropriate publicity, is provided by the Office of the Sheriff to give full public recognition to those who have brought honor to themselves, the Office, and Queen Anne's County.

The purpose of this directive is to establish the types of awards and commendations that will be awarded, those who are eligible for each award, and the mechanism for the selection of members who may have obtained such recognition.

II. Policy

It is the policy of the Office of the Sheriff to identify those members of the Office who have exceeded standard levels of performance in specific areas of their duties, and provide appropriate recognition in the form of awards and commendations. In addition, allied agency personnel may also be recognized through a Sheriff's Commendation.

III. Awards Committee

The awards committee will consist of a minimum of five (5) members from the Office of the Sheriff who are appointed by the Chief Deputy or his designee and identified to all personnel upon selection. At least three of the members shall be sworn personnel.

One member of the board will be appointed Awards Committee Coordinator. Each board member will serve at the discretion of the Chief Deputy or his designee.

The Committee Coordinator will maintain minutes of each meeting, as well as order the appropriate plaques and print all certificates for the nominees. The Quartermaster is responsible for ordering appropriate uniform pins and medals for the nominees as requested by the Committee Coordinator.

The Awards Committee will meet periodically as directed by the Committee Coordinator to consider all recommendations throughout the year (At least three times per year). The Awards Committee is given access to all information regarding each nominee recommended, and may investigate the circumstances surrounding the recommendation in any manner it deems necessary to verify information. The Awards Committee forwards all recommendations and the results of their investigations to the Sheriff by way of the Chief Deputy or his designee through interoffice correspondence.

IV. Nominating Procedures for Awards and Commendations

It is the responsibility of each Sergeant and all Division Commanders to nominate members of their respective units for appropriate awards. However, all members of the Office of the Sheriff, regardless of rank, are encouraged to recognize outstanding performance of sworn personnel, civilian personnel, allied agency personnel, and business/community leaders.

V. Awards Nomination Form Nominations must be submitted in writing to the Committee Coordinator by utilizing the appropriate Nomination Form, which shall be maintained in electronic format. Once the form is completed and submitted, containing all appropriate information, the Committee Coordinator shall maintain the form in an accessible file. The nominations can be submitted throughout the calendar year in question; however, will not be considered after January 10th of the following year as the Awards Banquet will be held in February or March of each year (If no schedule conflicts arise). The awards Committee Coordinator will retain all submissions received for consideration for a minimum of three years.

VI. Award Nomination Selections

The Committee Coordinator will convene the Awards Committee at least three times per year to consider nominations and to prepare for the awards banquet. Award nominations will be reviewed by the Awards Committee Board no later than January following the calendar year in question. The winning nominees will be determined by a majority vote from the board members for each selected award. The Committee Coordinator will abstain from voting. Upon completion of the nominations for the calendar year, recommendations will be forwarded to the Chief Deputy or his designee through written interoffice correspondence. The recommendations will be submitted along with a copy of the original recommendations and any supporting documentation.

If an Awards Committee Board Member is nominated by another deputy, the affected board member shall excuse himself/herself from the board meeting and the vote for that particular award nomination. The board member can return to the meeting once the vote has taken place. This is done to maintain a fair and impartial voting process. A board member is not permitted to vote themselves in for an award. A submission for a board member must be submitted by another board member or other member of the Office of the Sheriff not affected by the nomination. A majority vote shall prevail to award the nomination for a particular award.

VII. Written Notification of Award Nominees

Once nominees have been selected the Awards Committee nominations will be forwarded to the Chief Deputy or his designee by way of written interoffice correspondence and include a complete list of each award recipient. The nominations will then be forwarded to the Sheriff. All nominations submitted will be accompanied by the original recommendation and any supporting documentation. Once a final selection of award nominees has been made, the Sheriff's Executive Assistant shall immediately mail written notifications to all award recipients acknowledging their selection of an award and to request their attendance at the annual awards banquet. The written correspondence shall not reveal what type of an award will be given just that the selected deputy shall receive an award.

VIII. Maintenance of Records by the Executive Assistant

Once the award nominee selections are final, the Sheriff's Executive Assistantwill maintain a permanent file of the nominations approved by the Awards Committee and the Sheriff. Additionally, copies shall be maintained in the nominees' personnel files. The PIO will assist the Sheriff's Executive Assistant in developing and/or creating a power point presentation for the yearly awards banquet.

IX. Awards Banquet

All Awards and Commendations will be presented during an annual Awards Banquet Ceremony in February or March of the calendar year following the nominations if possible. The date, time, and location of the Awards Ceremony will depend on facility availability, but will occur no later than the end of March each calendar year. If this is not feasible, the Sheriff or his/her designee will present any awards and commendations as soon as possible.

The Awards Committee will be responsible for planning and making all the necessary arrangements for the Annual Awards Ceremony. This shall be accomplished financially through fund raisers and Office of the Sheriff funds allotted within budget.

X. Awards Order of Precedent

The following awards and uniform pins are to be worn on the uniform in order of precedence. The order in

this policy will show from the highest award to the lowest award in succession. It is noted that this policy will also show what each award recipient shall receive at the annual awards banquet for each award.

- 5. Purple Heart Award (Medal, Pin & Certificate)
- 6. Lifesaving Award (Plaque, Pin & Certificate)
- 7. Sheriff's Commendation Award (Plaque, Pin & Certificate)
- 8. Meritorious Unit Citation Award (Pin & Certificate)
- 9. Outstanding Patrol Performance Award (Pin & Certificate)
- 10. Narcotics Enforcement Award (Pin & Certificate)
- 11. DUI Enforcement Award (Pin & Certificate)
- 12. K9 Commendation Award (Pin & Certificate)
- 13. The Patriot Award (Pin Only / One Time Award)
- 14. Distinguished Volunteer Service Award (Plaque & Certificate)

XI. Order of Wear on the Uniform

All ribbons shall be worn on the uniform on the right side above the name plate. All ribbons shall be worn from top to bottom in order of precedent (Highest to Lowest). All previously issued ribbons for Office of the Sheriff personnel that have been re-issued under this policy may exchange their older ribbons for new one's pertaining to the appropriate award. Awards issued to deputies from outside agencies may only be worn at the discretion of the Sheriff.

XII. Awards Prerequisites

A. Medal of Honor Award

The Medal of Honor is awarded to deputies who distinguish themselves through extraordinary bravery, heroism, and selflessness. The deputy must have been aware of the imminent threat to their own personal

safety and have acted "Above and Beyond the Call of Duty," at the risk of their own personal safety and/or their life. The nominee receives a medal, pin, and certificate.



NOTE: The nominee for this award shall be considered for entry into the Maryland Sheriff's Association Deputy of the Year Award, which takes place at the annual Maryland Sheriff's Association Banquet.

B. DFC Jason Schwenz Award

The DFC Jason Schwenz Award is presented yearly to members of the Office of the Sheriff who have made extraordinary contributions to Law Enforcement throughout their career, and who exemplify the character and dedication of DFC Jason Schwenz by consistently performing above and beyond their required duties. This shall be considered one of the most prestigious awards given to a deputy in the Office of the Sheriff due to the ultimate sacrifice given by DFC Jason Schwenz. The nominee receives a medal, pin and certificate.

At the annual awards banquet, a member of the immediate family of DFC Jason Schwenz, if available, shall present this award to the nominated deputy.

C. Deputy of the Year Award

The Deputy of the Year Award is presented at the annual awards banquet to the Deputy in recognition for his/her outstanding overall performance during the prior calendar year. The Awards Committee shall take into consideration the prior year's statistical data when considering nominees for this award. The recipient receives a medal, pin and certificate.

D. Legion of Honor Award

The Legion of Honor is awarded to deputies that have affected the arrest or assisted in the capture/arrest of a person who was a major threat and/or risk to the community. The receives a plaque, pin and certificate.



E. Purple Heart Award

The Purple Heart shall be awarded to deputies who are injured while serving in an official capacity as a Law Enforcement Officer. The injury sustained must have been as a result of a life threatening situation, or a permanent injury received as a result of any official action or self-sacrifice, and not by carelessness on the part of the deputy. The recipient receives a medal, pin, and certificate.



F. Lifesaving Award

The Lifesaving Award is presented to deputies for saving human life, whereas, if not for the direct action of the deputy, in all probability the life would not have been saved. Documentation and other supportive evidence, such as statements from physicians, witnesses, and/or other deputies should be included with the original recommendation. If a deputy's action led to the prolonging of life to the extent that the victim was released to the care of medical authorities, he/she is also eligible to receive this award even through the victim may expire at a later time. The recipient receives a plaque, pin, and certificate.



NOTE: The recipient of this award shall be considered for entry into the Maryland Sheriff's Association Deputy of the Year Award, which takes place at the annual Maryland Sheriff's

Association Banquet.

G. Sheriff's Commendation Award

The Sheriff's Commendation Award is awarded to any member or unit of the Office of the Sheriff, or allied agency personnel, for an outstanding accomplishment that resulted in improved administration, operations, or substantial savings in manpower or operational costs, where the recipient or recipients have gone above and beyond the requirement of his/her normal assignment to contribute to a more effective and efficient law enforcement service, or for outstanding performance that brought great credit to the Office of the Sheriff and or Queen Anne's County in a case of unusual public interest.

This award is solely decided upon and selected by the Sheriff and not by the Awards Committee. However, the Awards Committee may submit nominations to the Sheriff for consideration. The nominee receives a plaque, pin, and certificate. If an allied agency member is nominated to receive this award, the recipient member shall receive a plaque and certificate only, not a uniform pin.



H. Meritorious Unit Citation Award

The Meritorious Unit Citation is given to only one (1) unit per year within the Office of the Sheriff, which has gone above and beyond the call of duty in the performance of their law enforcement responsibilities. For purposes of this award a unit is defined as any division, unit, group, or team that works together to accomplish a common goal. The unit selected for this prestigious award should have displayed exemplary performance throughout the calendar year. All units within the Office of the Sheriff are eligible for this award to include: Administrative Services, Field Operations, Support Services, Sheriff's Resource Unit, School Resource Officers, Criminal Investigations, Drug Task Force, K9, Circuit Court Security, the S.W.A.T. Team, and the Civilian Clerical Staff. The recipients receive a pin and certificate.



I. Outstanding Patrol Performance Award

The Outstanding Patrol Performance Award is presented to one (1) patrol squad from the Field Operations Division which has made outstanding contributions toward keeping the communities safe through criminal and/or traffic enforcement, by performing an exceptional amount and/or quality of law enforcement activity, developing and implementing effective operational strategies or tactics, or consistently conducting skillful or persevering investigation of an arduous or complex task. As additional criteria for this

award, the Awards Committee shall take into consideration yearly statistical performance when comparing all patrol squads for the entire calendar year in their law enforcement responsibilities. Each member of the recipient squad receives a pin and certificate.



J Narcotics Enforcement Award

The Narcotics Enforcement Award is given to up to two (2) deputies with the highest statistical performance in Narcotic investigations leading to the arrest of persons for violations of

the Controlled Dangerous Substance laws. Statistical performance includes on view arrests and charging documents issued, which need not be served to get credit for the arrest. **Deputies assigned to the Queen Anne's County Drug Task Force are excluded from consideration for this award.** The recipient receives a pin and certificate.

The deputy with the top statistical performance for this award throughout the Office of the Sheriff will additionally be awarded the opportunity to attend aggressive Narcotic Enforcement Training (when available) to include but not limited to: The "Top Gun" Undercover Narcotics Investigator School given at Ft. Indiantown Gap Military Training Base in Pennsylvania, and/or attend the MAGLOCLEN annual

Narcotics Conference in Ocean City, Maryland. The Awards Committee board members will forward the nominated deputy selection to the training coordinator who shall be responsible for registering the top award recipient for this training.



K. DUI Enforcement Award

The DUI Enforcement Award is given to up to two (2) deputies with the highest statistical performance in DUI/DWI investigations leading to the arrest of persons for violations of all laws pertaining DUI/DWI. Statistical performance includes on view arrests and any charging documents issued at a later time. The recipient receives a pin and certificate.

The deputy with the top statistical performance throughout the Office of the Sheriff in this area will additionally be awarded the opportunity to attend the annual MADD Awards banquet. The Awards Committee board members will forward the nominated deputy selection to the training coordinator who shall be responsible for registering the top award recipient for this training.



L. K9 Commendation Award

The K9 Commendation Award is given to one

(1) deputy per year within the K9 Unit who displays exceptional expertise and performance in the areas related to K9 enforcement, and who displays great credit upon the Office of the Sheriff. The recipient receives a pin and certificate.



NOTE: If feasible the awarded deputy shall also be considered to attend additional K9 training when available.

The Awards Committee board members will forward the nominated deputy selection to the training coordinator who shall be responsible for registering the award recipient for this training.

M. The Patriot Award

The Patriot Award is a one (1) time award given to each deputy for their dedication to the Defense of the United States Constitution, the State of Maryland, and the local laws and ordinances of Queen Anne's County. Additionally, this award is given for the Protection of the United States Flag. The recipient receives a pin only.



NOTE: Each deputy is given this award only once. When a new deputy is hired this award will be issued at the next annual awards banquet to that deputy.

N. Distinguished Volunteer Service Award

The Distinguished Volunteer Service Award shall be awarded to a deputy and/or citizen who have selflessly volunteered themselves and their time to improve services within the community in which they live/work. Furthermore, the Office of the Sheriff seeks to further the acceptance of these duties through recognition of both deputies and citizens whose actions have contributed to the accomplishment of the Office's mission or the safety of the community. The recipient receives a plaque and certificate.

NOTE: This award is now combined with the Citizens Recognition Award from previous policy.

O. Honor Graduate Award

The Honor Graduate Award is awarded to one

(1) deputy in a Police Training Academy who consistently displays exceptional performance while in training. The deputy who is awarded this honor shall be selected with the top statistical performance when compared to other trainees in the areas of grade point average, physical skills average, shooting, testing scores, driving scores, hand to hand combat, physical performance testing, and practical application scores.

If there is only one trainee in a police academy for the calendar year, the sole deputy to be selected for this award shall maintain a Grade Point Average for all categories listed with a minimum of 90%. The training coordinator maintains consistent interaction with these deputies while in the academy and therefore, he/she is best suited to nominate and/or provide documentation to the awards committee regarding this nomination. The recipient receives a pin and certificate.



P. Years of Service Award

The Years of Service Award shall be awarded to both sworn and civilian personnel for their years of service to the Office of the Sheriff, which shall proceed at five (5) year increments during employment. The recipient receives a pin only.



Q. Civilian Service Employee Award

The Civilian Service Employee Award shall be awarded to a civilian staff member of the Office of the Sheriff for exceptional performance by civilian staff in the performance of their official duties. The recipient receives a plaque, pin, and certificate.



R. Exceptional Driving Skills Citation The Exceptional Driving Skills Citation is awarded to deputies who display safe driving skills for a period of five years in which the deputy has had no preventable departmental accidents, nor had any negative Job Observation Reports for bad driving habits. The recipient receives a certificate only.

S. Business Owners Service Award

The Business Owners Service Award is awarded to businesses that have consistently contributed their time and support to Law Enforcement as well as their community. The recipient receives a plaque and certificate.

T. Sheriff's Quarterly Award

The Sheriff's Quarterly Award is awarded to any employee of the Office of the Sheriff for going above and beyond their normal duties, and for displaying daily initiative to achieve the mission of the Office. This award is solely decided upon and selected by the Sheriff and not by the awards committee. The recipient receives a plaque and certificate and may be presented to the recipient at a Command Staff meeting at the Sheriff's discretion.

U. Deputy of the Quarter

The Deputy of the Quarter Award is awarded to deputies who display exceptional performance in all areas of their job function for a particular quarter of the calendar year. This award recipient shall be agreed upon unanimously by the Division Commanders. If a unanimous decision cannot be reached by the Division Commanders, the file of recommendations will be referred to the Sheriff and Chief Deputy for their decision on the recipient. The presentation to the recipient may be made at a Command Staff meeting at the Sheriff's discretion.

V. Hazardous Duty Citation

The Hazardous Duty Citation is given to members of the Office of the Sheriff who have worked during a time of crisis and or state of emergency during inclement weather. The recipients will receive a certificate only.

W, Allied Agency or Civilian Recognition Award

The Allied Agency or Civilian Recognition Award is given to Allied Agencies or civilians who have provided assistance to the Office of the Sheriff above and beyond the normal course of business, provided assistance to a deputy in distress or made a significant contribution to the preservation of life, property or public welfare during a call for service in Queen Anne's County. The recipient will receive a plaque and certificate.
