## QACSO Announces Results of Tobacco Sale Compliance Checks Keeping Youth Safe, One Check at a Time

Queen Anne's County, MD (June 10, 2024): The Quen Anne's County Office of the Sheriff recently completed tobacco compliance checks on local retailers that sell tobacco products as well as electronic smoking device products.

Under the supervision of law enforcement officials, a series of operations between February 29<sup>th</sup>, 2024, and May 15<sup>th</sup>, 2024 were conducted wherein underaged individuals were deployed to 129 businesses in Queen Anne's County with the objective of confirming the establishment would refuse the sale of tobacco products to an underage customer, or a customer who is not able to provide valid identification. Seventeen retailers were found to be non-compliant with the law, two failed twice on separate dates. As a result, criminal citations were issued to the employees making illegal sales, per Maryland law.
